THESE PROGRAMS TAKE PLACE AT OUR CLUBHOUSE LOCATION AND ACTIVITIES INCLUDE CLUBHOUSE SATURDAYS AND SUNDAYS, FAMILY NIGHTS, HOLIDAY H.U.G.S, NEW MEMBER ORIENTATIONS, AND PARK BENCH. ON MARCH 13, 2021 KATE'S CLUB REOPENED ITS DOORS WITH IN-PERSON OUTDOOR PROGRAMMING WHILE MAINTAINING VIRTUAL PROGRAMMING AS WELL. THIS HYBRID PROGRAMMING MODEL CONTINUED THROUGH THE YEAR.

WE PROVIDE GRIEF TRAINING FOR PROFESSIONALS, ONE-TIME GRIEF EDUCATION ACTIVITIES FOR STUDENTS, CRISIS RESPONSE FOR SCHOOLS AND ORGANIZATIONS, AND IN-SCHOOL GRIEF SUPPORT GROUPS. IN TOTAL, KATE'S CLUB TRAINED 1,214 PROFESSIONALS IN 2021 AND SUPPORTED 186 STUDENTS THROUGH SCHOOL-BASED GRIEF GROUPS.
